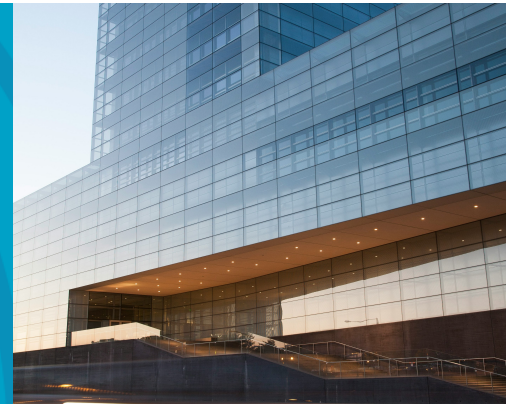

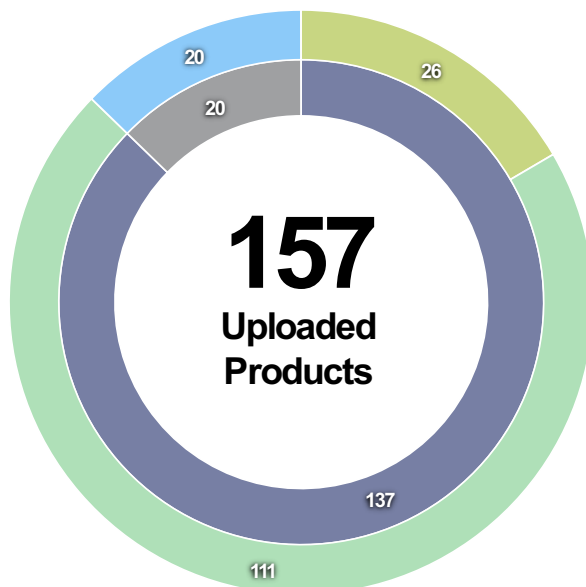
## Performance InCheck Report - December 2024

The Performance InCheck report presents a summary of the products utilized within Supplier's facility, along with the conformity of chemical products to the Chemicals to Zero Levels and the ZDHC MRSL Conformance Levels specified in the relevant ZDHC programs.

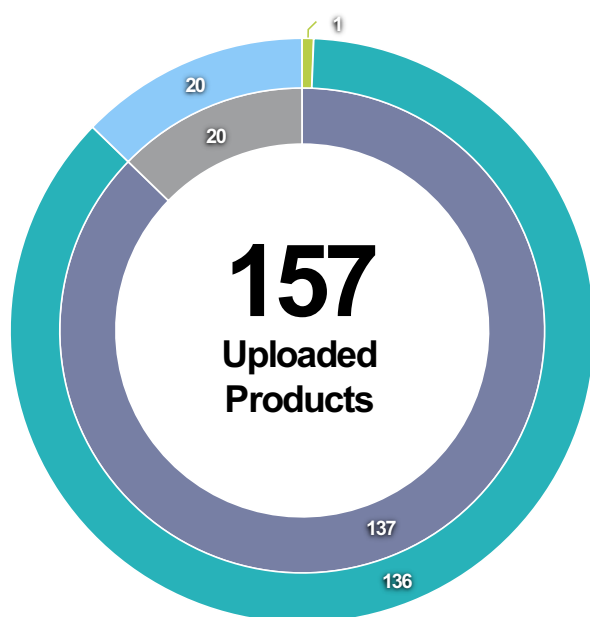

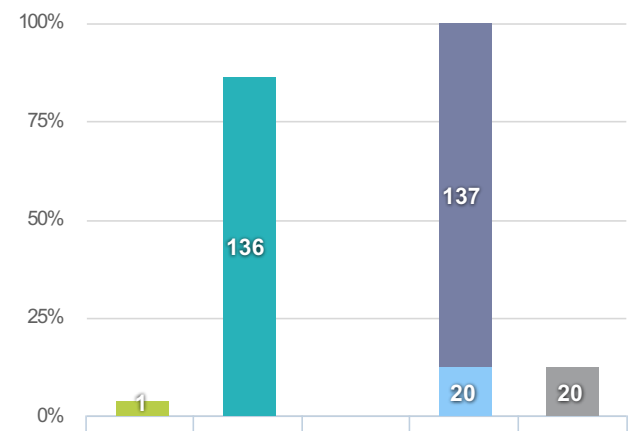
## Improve your Chemical Inventory Performance with these easy steps:

3. Invite your Chemical Suppliers (Formulators) to join the ZDHC Gateway, to upload and publish their products. Use the ["Invite Feature"](#) on the ZDHC Gateway to send the invites to your supply chain partners.
4. Ensure your staff is using the ZDHC Gateway Chemical Module to get information about high performing, safer chemical products before purchasing them, to keep a high Chemicals to Zero Level and respectively a high ZDHC MRSL conformance certificate.

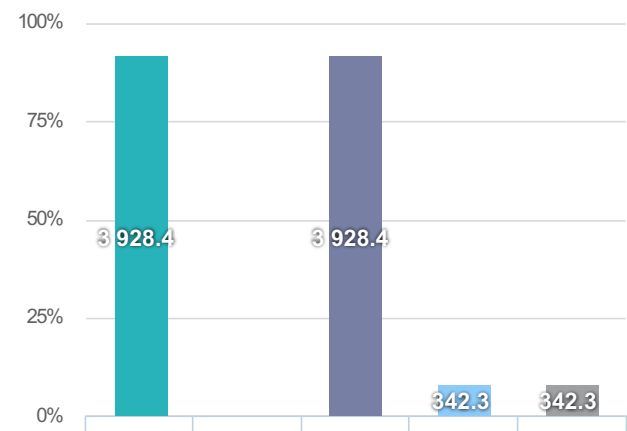


# Product overview by count and weight
